SKILLS ENHANCEMENT PROGRAM

- ❖ SHORT-TERM PROGRAM NOT DESIGNED FOR A (4) YEAR DEGREE
- ❖ PROGRAM REQUIRES STUDENT BE WORKING 20 HOURS A WEEK OR MORE
- ❖ GRADUATION OR COMPLETION OF PROGRAM MUST INCREASE EMPLOYMENT WAGES BY \$3.00 PER HOUR
- ❖ BE A RESIDENT OF DOOR, KEWAUNEE, MANITOWOC, CALUMET OR SHEBOYGAN COUNTY

INCOME TO BE COUNTED TOWARDS ELIGIBILITY

- ❖ GROSS WAGES/SALARY
- ❖ GROSS RECEIPTS FROM UNEMPLOYMENT
IF PAID WEEKLY YOU (X IT BY 4.3 TO GET GROSS MONTHLY)
- ❖ SOCIAL SECURITY
- ❖ WORKERS COMPENSATION
- ❖ ALIMONY
- ❖ MILITARY ALLOTMENTS
- ❖ SSI, SSDI
- ❖ WORK STUDY-NEED TO KNOW HOW MANY WEEKLY HOURS

INCOME NOT TO BE COUNTED TOWARDS ELIGIBILITY

- ❖ CHILD SUPPORT
- ❖ HIGHER EDUCATION GRANTS, SCHOLARSHIPS
- ❖ TAX REFUNDS/GIFTS
- ❖ NON-CASH BENEFITS (BADGER CARE, FOOD SHARE, HOUSING ASSISTANT)
- ❖ JOB CORPS PAYMENTS

“HOUSEHOLD “ COHABITANTS ARE CONSIDERED A HOUSEHOLD BOTH INCOMES MUST BE COUNTED IF

- ❖ THEY SHARE A CHILD
- ❖ SHARE PROPERTY (HOUSE, VEHICLE, BANK ACCOUNT)
- ❖ LIVE WITH PARENTS
